FLOOD PREVENTION AND LAND DRAINAGE (SCOTLAND) ACT 1997

This Act requires that Renfrewshire Council carries out flood prevention duties, an outline of which is detailed below.

The Act requires that we will:

Periodically assess specific areas to determine whether there is a likelihood of flooding;

Maintain the efficiency of flood defences and watercourses in order to reduce the likelihood of flooding;

Publish a report every 2 years on the actions taken and further measures proposed together with recording the occurrences of flooding of land since 26 November 1997.

Act upon our statutory duty to implement flood prevention measures.

We will in addition:

Respond to public concerns over specific flood events

Seek maximum funding and specific approvals from the Scottish Executive.

Use specialist consultants to assist in and review Renfrewshire Council's proposals.

Liaise closely with all interested parties who can facilitate flood risk reductions.

Prepare guidelines for road and housing developers to follow, and take account of, in their operations.

Maintain and develop information systems to enable Council Departments to take flooding aspects fully into account.

Increase efficiency and coverage of flood warning systems.

Partner with SEPA, Scottish Water and other Local Authorities in Europe to identify flood prevention solutions which can be replicated throughout Europe.
