## Possible Cancellation of Club Machine Permit: Blacklandmill Bowling Club

### 1. Summary

- 1.1. Paragraph 14 (1)(b) of Schedule 12 to the Gambling Act 2005 ("the Act") requires that premises granted a Club Machine Permit by the Licensing Board must pay an annual fee. In terms of regulations made under the Act, this annual fee is set at £50. The fee requires to be paid to the issuing authority before each anniversary of the issue of the permit.

### 2. Background

- 2.1. Blacklandmill Bowling Club was granted a permit which was issued on 1 September 2015 under the reference number CMP-035. The annual fee therefore requires to be paid each year by 31 August.
- 2.2. Correspondence was sent to the club committee on 7 July 2017 to advise them of the due date for payment of the fee. Further letters were sent to the club committee on 20 September and 18 October 2017 advising the club that the fee was now overdue for payment. To date the annual fee remains outstanding. In terms of Schedule 12, Paragraph 22(1) of the Act and the Regulations, the Board must cancel a permit in these circumstances unless satisfied that the failure to pay the fee is attributable to administrative error.

### 3. Recommendations

- 3.1. It is recommended that the Board hold a hearing to consider cancellation of the Club Machine Permit for Blacklandmill Bowling Club.
